## ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. AND WHEREAS, the institution ,Mahatma Gandhi University College of Teacher Education, Thodupuzha ,Idukki District 685535,Kerala has by affidavit-consented to come under New Regulations and sought for one basic unit in B.Ed.
- 3. AND WHEREAS, on scrutiny it is found that SRC in its 271<sup>st</sup> meeting held on 1<sup>st</sup> August, 2015 considered the complaint against the institution and decided to obtain comments from the University on the complaint received by this office. The University has submitted the comments to this office on 21.04.2015. The revised order is issued to the institution subject to the decision of SRC on the comments of the Registrar, M.G.University
- 4. AND WHEREAS, it has been decided to permit the institution to have one basic unit of 50 students.
- 4. NOW THEREFORE, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Mahatma Gandhi University College of Teacher Education, Thodupuzha, Idukki District 685585, Kerala for conducting B.Ed programme of two years duration with an annual intake of 50 students (one basic unit) from the academic session 2015-16
- 5. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 7. The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
  - a) Sanctioned programmes along with annual intake in the institution:
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c) Name of faculty members who left or joined during the last, quarter:
  - Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;

e) Fee charged from students;
